PROFESSIONAL EXPERIENCE

Being the senior advisor to the Chief Justice and the Minister of Justice in Bahrain allowed me to draft many legislations and regulations as well as develop the judicial court procedures. My work as an advisor has given a unique understanding of the working of the regional legal systems. I been working in the region for over 15 years.

Since 2017, I sat as an arbitrator in disputes under GCC Commercial Arbitration Centre rules as well as ad hoc and issued awards in both Arabic and English. I am a Member of the Chartered Institute of Arbitrators.

I completed an LLM from King's College London and PhD in international commercial arbitration from LSE. I am a qualified lawyer in both New York and Jordan and therefore familiar with both civil and common law systems.
